## Frequently Asked Questions

How do you verify whether something should be paid?

A reproductive lawyer will read through your agreement and identify expenses or payments to which the surrogate or egg donor are entitled, and any terms and conditions pertaining to those payments.

All compensation will be sent to the gestational surrogate or egg donor per the terms of the applicable agreement. Any questions about payments will be directed to the applicable agency, parent, or attorney for clarification prior to payment being issued.



How do agencies, surrogates and donors request reimbursements or payments?

Stork Escrow has forms available in its portal which may be submitted from any smartphone, tablet or computer.

However, monthly payments, including compensation payments due during a pregnancy will be sent automatically and do not need to be requested.

Payments are sent via ACH direct deposit so that funds are electronically deposited within 24-48 hours.
